Rev. Emmett Waite native of Napoli dies at eighty-two

The Rev. Emmett B. Waite, 82, of Route 242, Napoli, died at 4 a.m. Thursday, March 24, 1994, in his home.

He was born June 11, 1911, in the town of Napoli, the son of Emmett B. and Mertie Bushnell Waite.

A graduate of Altimont High School, in Altimont, N.Y., he attended Hope College in Holland, Mich., earned his masters in philosophy from Rutgers University in 1933, a bachelors in sacred theology from New Brunswick Seminary College in 1937, a bachelors in social science from New York University, and also attended Buffalo and Albany medical schools. He was a missionary in Mexico for eight years, and a minister in the Dutch Reformed Church in Glen and Hyde Park, retiring in 1975. He also taught social science at Dutchess and Ulster Community Colleges, and was a chaplain for the Dutchess County Jail.

Rev. Waite was citizen of the year in Hyde Park in 1964, a life member of Dutchess County Ambulance and Rescue Association, and former member of the Hyde Park Volunteer Fire Department and Rescue Squad. He was the first to establish and teach the fundamentals of ambulance and rescue, later know as EMT, and copied by many states. The New York State Department of Health has followed up his program which is still used today. He also taught **EMT** classes at Vassar Hospital and Dutchess Community College. A member of the Dutch Reformed Church, Hyde Park, he was also a member and former president of Hyde Park Rotary Club and the Little Valley

Rotary Club. Surviving are his wife, the former Marion Daley, whom he married June 12, 1937; a son, Thomas Waite of Hollywood, Fla.; and four grandchildren.

He was preceded in death by two brothers: Clayton and Francis Waite, and a sister, Clara Burroughs.

Funeral services were held at l p.m. Saturday, March 26, at Napoli United Methodist Church with the Rev. Daryl Hanson and Michael Trenchard officiating. The Van Rensselaer & Son Funeral Home, Randolph was in charge of arrangements. Burial was in Napoli Cemetery.

TAP awards for prison inmates is called an insult to taxpayers

Earlier this month, I joined other Assembly Republicans in an attempt to force debate on a bill which would end Tuition Assistance Program (TAP) awards for inmates in New York's prisons.

The bill would require convicts to repay the state six months after they complete their education or six months after they are released from prison, whichever comes later.

Unfortunately, Assembly Democrats defeated this measure along a party-line vote. Every family that has ever struggled to send their children to college should be disappointed in this vote.

Over the last decade, TAP awards have been dramatically cut at a time when college tuition grew by leaps and bounds. In addition, Regents scholarships were totally eliminated. Now, the governor, in his 1994-95 budget proposal calls on PAP awards for graduate

students to be phased out.

maximum of \$4,125 to the very neediest students and \$1,125 to the neediest graduate students, not very much compared to high tuition costs.

Yet, nearly 5,000 inmates have taken advantage of the TAP program at a cost to taxpayers of more than \$5 million. In 1992-93 nearly \$26 million of our tax dollars went to funding state prison education programs.

We are telling our citizens that they must pay their school taxes and college tuition, while those who commit some of the most heinous crimes in our state are provided free educational opportunities. This logic makes absolutely no sense.

The Senate passed legislation ending TAP for prisoners earlier in the year. Senate Majority Leader Ralph Marino summed up the issue best when he said, "We should not be rewarding criminals with fringe benefits that average New Yorkers do not have the opportunity to receive."
